Introduction

Palau Red Cross Society (PRCS) is a community-serving, community-based organization dedicated to being "the leading humanitarian organization in Palau that is inclusive, sustainable, effective and that meets the needs of the community." Participation in the organization's programs is subject to the observance of the organization's rules and procedures. Any participant or staff member who violates this Code is subject to discipline, up to and including removal from the program.

This Code of Conduct applies to all Staff <u>at all times during their service with the Society</u> – <u>both during and after working hours</u>. "Staff" in this Code refers to all PRCS employees, consultants, members, volunteers, and interns, as well as staff-on loan and all individuals working under the PRCS name and legal status.

This Code, whether signed or not, shall automatically form an integral part of all PRCS contracts of employment and conditions of service for all Staff.

Rules of Conduct

PRCS Staff are expected to be advocates and champions of vulnerable people everywhere and to act in accordance with the seven Fundamental Principles of the International Red Cross and Red Cross and

 accept any personal gifts, special payments or unusual hospitality favors.
- Employees / volunteers / members are ambassadors of the PRCS and represent the PRCS. Always treat others with respect and courtesy.
- Employees / volunteers / members should model Red Cross values of caring, honesty, respect and responsibility for program participants.
 At PRCS, all individuals are treated with fairness and equality regardless of sex, race, gender, religion, ethnicity, socio-economic status and ability/disability.
- Volunteers / Members are free to exercise their full liberties as citizens, including the right to express their personal convictions on issues such
 as social, economic, religious and political subjects. However, they must refrain from giving any impression that their views and positions are
 those of PRCS.

Actions Not Allowed include:

- Actual or threatened violence toward any individual or group.
- Endangerment of life, safety, health or well-being of others.
- Possession or use of alcoholic beverages or illegal drugs on PRCS's property or reporting to the program while under the influence of drugs or alcohol.
- Possession of dangerous or unauthorized materials such as explosives, weapons or other similar items on PRCS's property.
- · Failure to follow PRCS' policies or procedures.
- · Failure to cooperate with supervisor/leader/mentor.
