## **TYPHOON SURIGAE**

- Angaur State site visit and distribution of basic hygiene and relief items scheduled for today was postponed due to bad weather conditions. Date TBD by NEMO and communicated to PRCS Team.
- 50 hygiene kit supplies procured on 04/20/2021 in preparation for Angaur State deployment. Assembly and packaging of the hygiene kit done today by PRCS volunteers.
- Additional 100 hygiene kit supplies procured on 04/21/2021 to stock-up in preparation of upcoming State deployments prioritising the remaining remote islands of Peleliu, Sonsorol, and Hatohobei.
- Hygiene kit to include mosquito coils; Mosquito net approved to be procured and to be included in pre-positioned stocks.
- IDA Data Entry Team to continue 24-hrs. shifts starting today from 8:00pm to 8:00am April 22, 2021 in preparation for a report to the NEC by Friday, April 23, 2021.

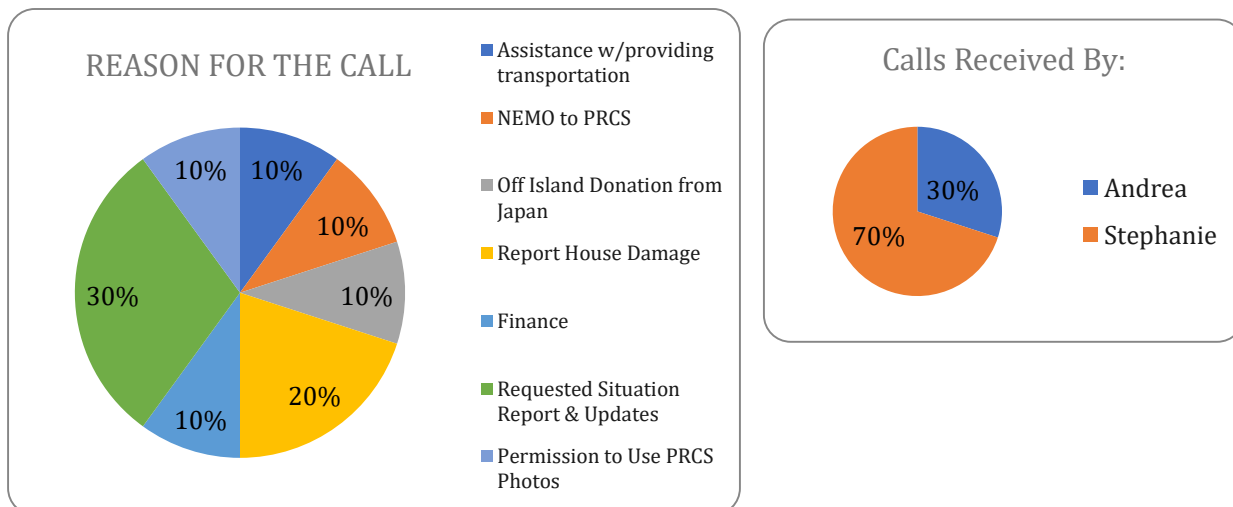

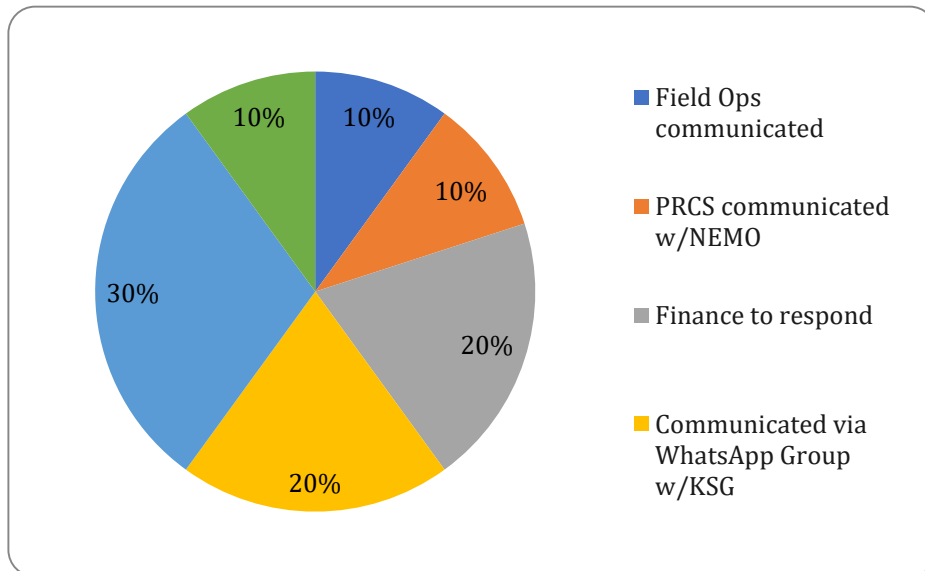
